Indian Customs Electronic Gateway (ICEGATE)

I. INTRODUCTION

The Indian Customs Electronic Gateway ("ICEGATE") is the national e-commerce portal of the Central Board of Indirect Taxes and Customs ("CBIC"). It acts as the digital interface for traders, importers, exporters, freight forwarders and other customs-related entities to submit documents and handle customs transactions electronically.

ICEGATE operates in accordance with various provisions under the Customs Act, 1962, and the Electronic Commerce guidelines issued by CBIC, enabling a secure, transparent and efficient customs clearance and compliance ecosystem.

II. PURPOSE

ICEGATE is established to:

1. Facilitate the filing of Bills of Entry (import goods declaration), Shipping Bills (export goods declaration), e-Payment of Customs Duty and other statutory documents electronically.
2. Support risk management systems (RMS), e-payment, document tracking and status monitoring.
3. Comply with the mandates of Section 17 (Self-Assessment), Section 46, Section 50 and other applicable sections of the Customs Act, 1962, for timely filing and clearance.
4. Fulfill India's commitment to World Trade Organization's (WTO) Trade Facilitation Agreement (TFA) by modernizing and digitizing customs procedures.
5. Legally validate the electronic submissions made, under the Information Technology Act, 2000, specifically under Section 4, which recognizes electronic records and Section 7, which allows such records to be retained and accepted as evidence in the same manner as physical documents.

III. KEY STAKEHOLDERS AND CORE COMPONENTS

1. ICEGATE is used extensively by:

- a. Importers and Exporters: To file Bills of Entry and Shipping Bills.

- b. Customs House Agents (CHAs): For submissions, queries, duty payments, and status updates.
- c. Banks: For e-payment of customs duties via the ICEGATE e-payment module.
- d. Logistics Service Providers: For manifest filing and tracking.
- e. Government and Regulatory Bodies: For integrated risk management, real-time intelligence sharing and audit trails.
